#### 1. Acceptance of Terms

1.1 Save The Deals / Digipaymium Limited ("**Save The Deals**", "we", "us" or "our") offers services enabling any user (the "User(s)") of the website [www.savethedeals.tw] (the "Website") who has subscribed and remain vaild as a member (the "Member(s)") to enjoy discounts and/or cash-back offers, to access to a range of information on e-tailers promotions and exclusive offers (collectively the "Service") on goods and services (collectively the "Products") offered by certain third parties (collectively the "Merchants") on the Website.

#### 4. Orders and Registration

4.1 Save The Deals is not the originator of any selected offers on the Website and do not act as a seller or an agent of any Merchant.

4.2 The Member wishing to subscribe to the Service must visit the Website or one of the mini-sites dedicated to one of the offers and click on the welcome offer which he wishes to access to. He must then follow the instructions on the Website, accept the Terms, provide information on the requested items and click "OK" to validate the request. He is then redirected to a secure payment page. On this secure page, Member must provide his credit card number linked to the account which he prefers the monthly subscription to be charged on. Member has the opportunity to check his order before confirming it.
